



## Background

The Queensland Family and Child Commission (QFCC) introduced its Forward Oversight Framework 2023–27 in June 2023 to provide better clarity about how it undertakes key statutory functions under section 9 of the *Family and Child Commission Act 2014* to review and improve the systems that protect and safeguard Queensland children and their families.

In 2023, the QFCC published the [2023–24 Oversight Forward Workplan](#), which sets out the discrete examination and discovery review projects to be prioritised over the 2023–24 financial year and beyond.

The Oversight Framework commits the QFCC to brief stakeholders on progress, to revisit the relevance of listed reviews, and to seek input and consider emerging issues to add to the workplan. Figure 5 in the Oversight Framework (p.15) outlines that the workplan is to be updated annually in January, with a progress update and outcomes to be reported annually in July.

## Process for updating the Forward Oversight Workplan


The 2023-24 Forward Oversight Workplan has been undergoing active review over recent months.


The review has included individual meetings with key agencies, staff input and written feedback from Ministers and Directors-General of key agencies and members of the QFCC Advisory Council on a draft 2024 workplan.










Feedback was received from several agencies. All feedback has been considered, and most has been incorporated.











The rest of this document outlines what has changed between the 2023–24 Forward Oversight Workplan, and the updated 2024 Forward Oversight Workplan.
