Self-placement

Analysis of the demographics, locations, patterns and rates of self-placement by cohort including a case file read to assess how safety assessment and practice responses are having effect.



Regulation of home education

A review of the prevalence of home education in high-risk home environments, including an analysis of the regulations of home education in Queensland.



Teenage parenting

An analysis of the factors that increase risk of young parenthood in Queensland, identifying and critically examining the services and responses currently in place.



Child car restraint use

A quantitative study to understand the use and impact of child car restraint in motor vehicle crashes.



Paediatric sepsis mortality

An analysis of sepsis related child deaths to better understand the incidence of childhood sepsis and identify opportunities to better identify, treat and prevent it.



Placement turnover, stability and self-placing

A quantitative analysis of the experience of children in out-of-home care looking at their placements, including comparison and practice changes across Australia.



Implementation of recommendations

An assessment of the actions taken in response to outstanding Royal Commission, CDRB and QFCC recommendations.



Exits from care

The project will review the current exit processes and measures used by the Department of Child Safety for children exiting out-of-home Care (OOHC) to determine the physical location of the children classified as exited from care.



Student disciplinary absences

Ensure the voices of marginalised children and young people who are suspended or excluded from school are heard.



Foster and kinship carer capacity

A joint project with PeakCare to assess the turnover of carer households in Queensland compared to other jurisdictions, with analysis of the carer cohort.

Redefining assault and neglect

The identification of appropriate definitions, classifications and screening criteria to more confidently identify types of assault and neglect, in order to gather information and determine how information should be reported.



Analysis of how family support programs are assisting to prevent young people's entry into Youth Justice. Review will include an economic lens on the impact of early intervention in youth justice building on work being undertaken by 54 Reasons and Australian Child Rights Taskforce.

Indicators of adversity and social vulnerability in child mortality

Defining, measuring and gathering data to build an evidence base on family-level adversity and social vulnerability and how this relates to child mortality.



Sudden Unexpected Deaths in Infancy

A quantitative study linking Perinatal data with the Queensland Child Death Register, to improve understanding of risk factors in sudden unexpected deaths in infancy (SUDI) by enhancing Child Death Register data with detailed health history from health records.

A compendium of stories by children and families across the life domains with specific focus on out-of-home care and youth justice cohorts.



Cognitive disability in youth justice cohorts

A review of undiagnosed cognitive disability in youth justice populations, its prevalence and role as a risk factor.



Parental neglect

A review of neglect cases to identify how poverty and support service access are factors in the assessment of "willing and able" and therefore shaping the experience of socially disenfranchised parents and families.

Child sexual abuse in Queensland

A quantitative look at the incidence of child sexual exploitation and the programs and policies in place to respond.



Intake and resubstantiation assessment

A quantitative assessment of how the child protection system is assessing risk and safety for children with a focus on how resubstantiation and renotification rates could be reduced.



Life outcomes for children in out-of-home care

An early look at the impact of implementing Support21 including a quantitative assessment of post-care life domain measures (i.e. housing, employment, health, etc.).



Residential care

A follow-up review of the residential care system. This will include a series of visits to care facilities, assessment of the cohort of the children in residential care (including the age, sibling group status and child protection history), review of service

delivery models and care standards.



Legal support for children and families in the youth justice system

A qualitative analysis of the views and experiences of children, parents and the sector about a child's access to and experience of legal advice they access in the youth justice system.



School achievement for children in out-of-home care

A quantitative compilation of the trends and changes in school achievement for children in care including performance, attendance and exclusion.



School reengagement

A quantitative and case file read on how young Queenslanders (particularly those with emerging youth justice exposure) are reengaged into education or employment programs.



Hearing families and children

An assessment of the child protection and youth justice complaints processes, including a mapping of the oversight entities practices and policies.

Mental health assessments in the youth justice system

An exploration and analysis of the fitness to plead, soundness of mind and Mental Health Court process, including mapping the frequency of assessments, impact of delays in the Childrens and Mental Health Courts and mechanisms for ensuring the prioritization of young people in the mental health court.

Discovery reviews



Re-imagining the response to offending by children and young people

An examination of alternative approaches to responding to offending committed by children and young people away from the criminal justice and legal systems. This project will involve an international scan of alternative models and their impacts and outcomes.



Responding to children as victims of domestic and family violence

A review of interventions specifically designed to respond to children in families where domestic and family violence (DFV) occurs, including an examination of their effectiveness at disrupting the intergenerational nature of DFV and its ongoing impact for individuals.



Blue Card deep dive

A forensic examination of the effectiveness of the Blue Car scheme, considering the implementation of past reforms and those recommendations that have not yet been made.
