### Oversight Forward Workplan

The Queensland Family and Child Commission (Commission) is charged with responsibilities to review and improve the systems that protect, safeguard and support Queensland children and their families. Our vision is that *Every Queensland child is loved, respected and has their rights upheld*. We pursue this vision by influencing systemic change that improves the safety and wellbeing of Queensland's children and their families.

Our *Oversight Framework* 2023–2027 articulates the model, principles and methodologies that apply to how the Commission delivers impactful reviews, audits and evaluations that influence positive change, and this document, the *Oversight Forward Workplan* 2025 (Workplan), contains the proposed future oversight work of the Commission as at March 2025.

The Commission develops a Workplan to set its systemic oversight priorities and ensure transparency. The Workplan is deliberately agile. While we list the topics we intend to examine, they are subject to review and revision to ensure the Commission's investment is focused on the areas most likely to have the greatest positive impact on Queensland children and families at the time. The Workplan undergoes regular priority review though a consultative approach and is published on the website annually.

The Commission uses a four-staged approach to scope and design its oversight work, applying an escalating approach based on the evidence and facts obtained in the earlier stages. The most intensive reviews, discovery and examination reviews, include dedicated resources and delivery against a formal project methodology. Our monitoring activities are deliberately agile and inform the need for deeper reviews.

The Commission becomes aware of review opportunities in several ways, mostly by means of working closely with our advisory councils, strategic partners, agencies, youth advocates, young people and families, and the general public. Issues may also be identified through data monitoring and review activities. Consultation with a range of stakeholders including government and non-government agencies, peak bodies, the community, and young people, guide the design and conduct of our review work.

The systems we provide oversight of are complex and multifaceted and there are many experts across Queensland working to reduce risks to children. The Commission values the expertise of others and proactively seeks to work with stakeholders undertaking related initiatives. This ensures that oversight decisions are informed, evidence-based, objective, and in the best interests of children and families.

The Commission's oversight prioritisation methodology guides decisions about what issues should be prioritised asking three key questions and considering the answers holistically:

- 1. What is the impact of the matter on children and families?
- 2. Is addressing the matter important to achieving the Commission's legislative objectives, strategic priorities, and explicit commitments?
- 3. Can the Commission influence the matter and is it the right agency to deliver impact and drive change?

#### **Examination reviews**

We extensively research, analyse and synthesise systemic issues and determine solutions-focused recommendations for change. We examine the broad system including the structural and relational elements driving an issue, the experiences of children, families and the sector and the changes needed to make improvements. We do this by undertaking a comprehensive review of the system in consultation with stakeholders and by gathering insights from children, families, the sector and the public. We gather submissions and facilitate consultation sessions and interviews to identify solutions for, and intended outcomes of, change.

#### **Discovery reviews**

We scan and analyse what is known about an issue and the broader system policy, program, practice and reform environment. We do this by gathering, reviewing and analysing legislation, policies, procedures, practices, literature, quantitative data and interjurisdictional models to understand the operating environment (including improvements underway) and intended outcomes for children and families. We engage young people, responsible agencies, sectors and other stakeholders to help identify the causes of the issue, the impact it is having on children and families and opportunities for improvement.

### **Future policy areas for review** in 2026 and beyond

- Provide advice regarding the design of a pilot program for GPS monitoring of high-risk domestic violence perpetrators
- Provide advice regarding the design and implementation of the Domestic and Family Violence Statewide Crisis Intake and Referral Service expansion across Queensland
- Provide proactive policy advice to guide the development and implementation of circuit-breaking sentencing—an alternative to detention that delivers an intensive rehabilitation program for youth offenders
- Provide evidence-based design principles to support the implementation of Youth Justice and crime early intervention schools, as well as initiatives that help young people disengaged from education access alternative pathways into training and education
- Provide proactive policy advice to inform the delivery of a 12-month post-detention transition program to reduce recidivism rates
- Contribute evidence-based policy advice regarding the design and delivery of educational initiatives in youth detention
- Support the design of additional Step Up, Step Down specialist mental health services for young Queenslanders
- Assess the implementation and uptake of the professional foster care scheme, including participation levels, regional distribution and emerging barriers or enablers.

### **Monitoring and Insight Reviews**

We look for patterns and relationships in evidence to more precisely identify issues, and determine whether or not further discovery action is needed. We raise issues with responsible agencies for their consideration and action and/or determine whether the issue should be listed on the Commission's forward oversight agenda for further discovery work.
